### SENIOR FULL PRIVILEGE

Includes all privileges of the Club; use of golf, tennis, swimming, fitness center, and clubhouse facilities for the Member and spouse. NOTE: the Senior Full-Privilege membership is available only to those over the age of 62 years.

**Initiation Fee: \$1,000.00    Monthly Dues: \$140.00**

### JUNIOR FULL PRIVILEGE

Includes all privileges of the Club; use of golf, tennis, swimming, fitness center, and clubhouse facilities for each individual in the Member's immediate family i.e. spouse and unmarried children living at home under the age of 21 years. NOTE: The Junior Full-Privilege membership is available only to those under the age of 30. Upon turning the age of 30 years, dues will increase to the Full-Privilege amount.

**Initiation Fee: \$1,000.00    Monthly Dues: 140.00**

### MILITARY—ACTIVE/RETIREE

Includes all privileges of the Club; use of golf, tennis, swimming, fitness center, and clubhouse facilities for each individual in the Member's immediate family i.e. spouse and unmarried children living at home under the age of 21 years. Must present military ID and/or CAC-Card.

**Initiation Fee: \$0.00    Monthly Dues: Active-\$75.00**  
**Initiation Fee: \$1000.00    Monthly Dues: Retired-\$125.00**

### NON-RESIDENT FULL PRIVILEGE

Includes all privileges of the Club; use of golf, tennis, swimming, fitness center, and clubhouse facilities for each individual in the Member's immediate family, i.e. spouse and unmarried children living at home under the age of 21 years. To qualify, the Member must live in an area outside of Dougherty or Lee Counties.

**Initiation Fee: \$1,000.00    Monthly Dues: \$140.00**

### SOCIAL/TENNIS
